#### 1. **APPLICATION**

- The Applicant warrants that:
  - it has the legal capacity to enter into the formal REISA Residential Tenancy Agreement ("Residential Tenancy 2.1.1 Agreement") which was made available to the Applicant by the Agent for inspection;
  - all information provided to the Agent in relation to this Application is true and correct and the Applicant undertakes 2.1.2 to promptly advise the Agent of any change to that information;
- 2.2 The Applicant acknowledges that:
  - it must sign the Residential Tenancy Agreement as soon as reasonably practicable following acceptance of this 2.2.1 Application by the Landlord;
  - 2.2.2 it is not entitled to take possession of the Property until the Residential Tenancy Agreement is signed by the Applicant and returned to the Agent; it agrees to pay the Rent during the Term in accordance with this Application and the Residential Tenancy Agreement;
  - 2.2.3
  - it must provide the Bond plus an amount equal to two (2) weeks' rent in cash or by bank cheque before 2.2.4 taking possession of the Property.

#### 3. **AUTHORITY**
